- SVIOA has typically had two individuals serve as Delegates to the annual World Service Business Conference. In 2022, SVIOA welcomed the groups from the former Northern Nevada Sierra Intergroup (NNSI). With that welcome, SVIOA agreed to allow the NNSI World Service Business Conference Delegate, to remain in that role on behalf of SVIOA. So, in 2022, SVIOA had three WSBC Delegates. <u>The question is</u>: **Do we want two or three WSBC Delegates?**
 - Jan invited IG reps to share the opinions of the individual groups. There were no volunteers, so she called for a vote.
 - 37% of the vote was for 2 delegates, 63% in favor of having three. This is substantial unanimity. This means that SVIOA will have three World Service Delegates. Since Judy L. will be in the middle of her term in 2023, that leaves two positions available for nomination.

New Business:

- Jan reported that she'd received a request to be on our speaker list from someone
 that wasn't in our area and doesn't attend our meetings. Jan declined the request
 but did ask Intergroup members for feedback. No vote is called for at this time.
 There was some discussion on the matter:
 - Rosalie reports that she recently signed up to be on a speaker list originated somewhere on the other side of the country.
 - Kathryn K reports that she finds it fascinating when new speakers, possibly from out of the area, chair/speak in meetings. She agrees that it makes it more challenging to whomever is managing the speaker list.
