SVIOA does not need money as we donated over \$9000 to entities in 2017. This would cause the retreat to be looked at as recovery focused and more positive than "fund raiser". The gift card idea was brought by Judy B in AZ they did this to attract more ticket buyers having more items to raffle off. Grace to research about the idea of self-supporting through contributions instead of solicitation for fund raising. Some discussion from floor: Is this for 2019 retreat or 2018 since some groups might have already been asking for collections to go towards cards. Will be brought up as new business next month by Grace after she does some research.
